Dear Comrades,


As per the call given by the Central Joint Council of Action, New Delhi the members of JCA all over the country are participating in the agitation program from 01.04.2017. In this regard resolution passed on 18.04.2017 was already submitted to Pr.CCIT, AP & TS, Hyderabad for onward transmission to the Chairman, CBDT, New Delhi. The program of agitation was initiated against the indifferent attitude of CBDT towards the long-pending demands of the officers/officials of the Department.

The Charter of Demand that was served upon the CBDT on 15-03-2017:


- I. Stop outsourcing of the regular official works of the Department.
- II. Finalization of pending Recruitment Rules of Gr. B & C as per the discussions with JCA.
- III. Filing up all vacancies by way of Promotion/ Upgradation/ Regularisation/ Relaxation in RRs in various cadres with due consequential promotions in the lower cadres and lifting the ban on promotion in some cadres.
- IV. Implementation of the CAT verdict relating to revision of the Pay-scale of ITO and ITI (as per 5thCPC Report) w.e.f. 01-01-1996 and refixation of pay of Inspectors to 7450/- from 01-01-2006 as per the Judgment of CAT, Pr. Bench.
- V. Procurement of Laptop AO/PS/Inspector cadres.
- VI. Stoppage of excessive and repetitive Reports.
- VII. Restoration of Zonal/Regional Recruitment in the cadre of Gr.-C to tide over the huge vacancies.
- VIII. Staff-car Drivers to be merged with the main-stream cadres, with relaxation or to restructure the cadres to reduce huge stagnation.

Accordingly, the outsourcing of Data Entry Work and Secretariat Assistant has been stopped in AP & TS Charge. A meeting with the Chairman, CBDT and Central JCA on 21-04-2017 and the Charter of Demands were discussed at length. However no concrete proposal / commitment was made by Chairman in the said meeting. Hence, the Central JCA has called for to observe **Day-long Dharna in front of all Pr.CCIT offices on 04-05-2017. All the members are requested to participate in Day Long Dharna on 04.05.2017 and make it grand success.**
